25 Finally the Truth

If you are reading this chapter then it means you are in possession of the third edition of my book 'Oppenheimer's Deadly Toys - the nuclear weapons hoax' available from Amazon as E-book and paperback ISBN 9798861530941.

A copy of a document came into my possession in August 2025. It is the Manhattan Project's "Interim Committee" meeting minutes of 31.5.1945. That document confirms that in 1945 USA had insufficient Uranium to build the Atomic bombs that were claimed to have been used later in August 1945.

Read the document <u>HERE</u>. The relevant text is at S II on P3 where Dr A H Compton and Dr E Fermi of the Manhattan project explain the state of play.

Dr Compton was the director of the Met-Lab at the University of Chicago. He oversaw the production of enriched uranium and plutonium for the bombs. Dr Fermi was the creator of the world's first artificial nuclear reactor. Both were leading scientists on the Manhattan project.

Here is an extract of the relevant text:

Dr A H Compton "The first stage involved the separation of uranium 235. The second stage Involved the use of "breeder" piles to produce enriched materials from which plutonium or new types of uranium could be obtained. The first stage was being used to produce material for the present bomb while the second stage would produce atomic bombs with a tremendous increase in explosive power over those now in production. Production of enriched materials was now on the order of pounds or hundreds of pounds and it was contemplated that the scale of operations. could he expanded sufficiently to produce many tons. ... It

was estimated that from January 1946 it would take one and one-half years to prove this second stage in view of certain technical and metallurgical difficulties, that it would take three years to get plutonium in volume ..."

Dr Fermi "estimated that approximately twenty pounds of enriched material would be needed to carry on research in current engineering problems and that a supply of one-half to one ton would be needed for research on the second stage."

First a word about the terminology used:

"The first stage involved the separation of uranium 235".

This refers to separating the isotope U235 from U238 to produce 100% of the fissile and less radioactive U235. Natural uranium metal contains concentrations of 99% U238, 0.7% U235 and 0.3% U234. Therefore to obtain 1 metric tonne of U235 you need (1/0.7%) 142.8 metric tonnes of natural uranium. Natural uranium is found in various concentrations in uranium ore, details are in C8. You may need 1,000 metric tonnes of uranium ore to obtain 1 metric tonne of natural uranium. Their supplies were not unlimited see C8.

"The **second stage** Involved the use of "breeder" piles to produce enriched materials from which plutonium or new types of uranium could be obtained".

This refers to making uranium fuel rods for reactor operations. and the production of plutonium, a byproduct of nuclear fission. Today these types of reactors are referred to as breeder reactors and they differ in configuration from those used to generate electricity. The fuel rods usually contain about 5% to 7% U235 and the remainder is U238.

The 'meeting minutes' unequivocally state that it would not be until 1949 that there would be a sufficient quantity from 'the second stage' for a plutonium weapon to be tested and then deployed. You can see how complicated the method is in C8 to C12 of this book.

The uncomfortable truth therefore, is that USA had insufficient plutonium to build the Gadget and test it at Trinity site on 16.7.1945, and that they had insufficient plutonium to build the Fat Man bomb and deploy it to destroy Nagasaki on 9.8.1945. If we accept the meeting minutes as fact then these two events never happened. We have been lied to for 80 years. The Demon Core handling incidents are also bogus.

The situation concerning the Little Boy bomb claimed to have been dropped on Hiroshima 6.8.1945 is less clear. This bomb had never been tested. Lets highlight this point, the first ever Atomic weapon **HAD NOT BEEN TESTED** prior to its alleged use. This was 64.1kg of HEU i.e. 80% U235 and 20% U238. To make this amount of HEU 7.3 metric tonnes of natural uranium (not uranium ore) are needed, the details are in C8. Furthermore the bomb could not have caused a massive destructive blast because nuclear fission does not cause explosions and secondly a nuclear fission chain reaction and intense heat and radiation would not have occurred because the bomb was lacking a moderator, refer summary points 1 and 2 below.

Dr Fermi says they needed 'one-half to one ton' of enriched material for research on the second stage. We have already said that 1 metric tonne of U235 requires 142.8 metric tonnes of natural uranium and possibly 142,800 metric tonnes of uranium ore to obtain it. I have detailed how much ore they had in C8. Whether this took priority over Little Boy is unclear except to highlight that Little Boy was never tested and could never work and we were lied to about Nagasaki etc.

Returning to Little Boy bomb and their requirements for 7.3 metric tonnes of natural uranium to make sufficient U235, we need to also consider the time required to manufacture it. The isotopic separation process is described in C11. At the outset of the Manhattan project in 1942 they estimated that 1 gram of 80% enriched Uranium would take 27,000 years to make. Consequently part of the Manhattan project was finding a better and faster way to make weapons-grade uranium. In C11 I document an interview with Hans Bethe a leading Manhattan project

scientist, by 1945 the process had improved and it might have taken 15 years to manufacture the U235 for the bomb. Clearly they could not do this in the available time frame.

It seems obvious therefore that they had insufficient enriched uranium to build the Little Boy bomb and deploy it (untested) to destroy Hiroshima on 6.8.1945.

The Manhattan Project's "Interim Committee" meeting minutes of 31.5.1945 could stand as evidence in a court of law. It is therefore beyond reasonable doubt that Hiroshima and Nagasaki were NOT subject to a nuclear holocaust.

Everything you have been told about the destruction of Hiroshima and Nagasaki is a lie. The testing of Gadget at Trinity test site never happened and the film Oppenheimer is embarrassing propaganda. The videos of Colonel Paul Tibbets and his testimony about the mission in B29 'Enola Gay' to drop the Bomb on Hiroshima is a fiction. Similarly Major Charles W. Sweeney's mission to Nagasaki in B29 'Bockscar' is also bullshit.

Do nuclear weapons exist today? I have already addressed this in my book. Here is a summary:

1 All explosions are gas related. The byproducts of nuclear fission are 94% heat and 6% radiation. No gas is produced by nuclear fission and so there can be no massive destructive blast. Refer C7.

2 To achieve intense heat from nuclear fission, millions of atoms need to be split in a chain reaction. This requires a moderator to slow down free neutrons. A moderator is not included in a bomb because there is insufficient time available to slow down neutrons. Therefore there can be no intense heat. Refer C6

3 An H-bomb otherwise known as a fusion bomb is a two stage device. it requires an A-bomb (fission bomb) as a first stage to generate the intense heat required for fusion to take place. If the first stage doesn't work then neither does the second stage. Therefore there can be no nuclear fusion taking place. Refer C19.

Therefore there are no such things as nuclear weapons. The minutes of the "Interim Committee" meeting is the smoking gun.

To misquote H G Wells who (allegedly) wrote the foreword to this book - The world has been set free from this scientific tyranny.

Do I get a ticker-tape parade for wiping these bogus events from the face of history?

Further action:
